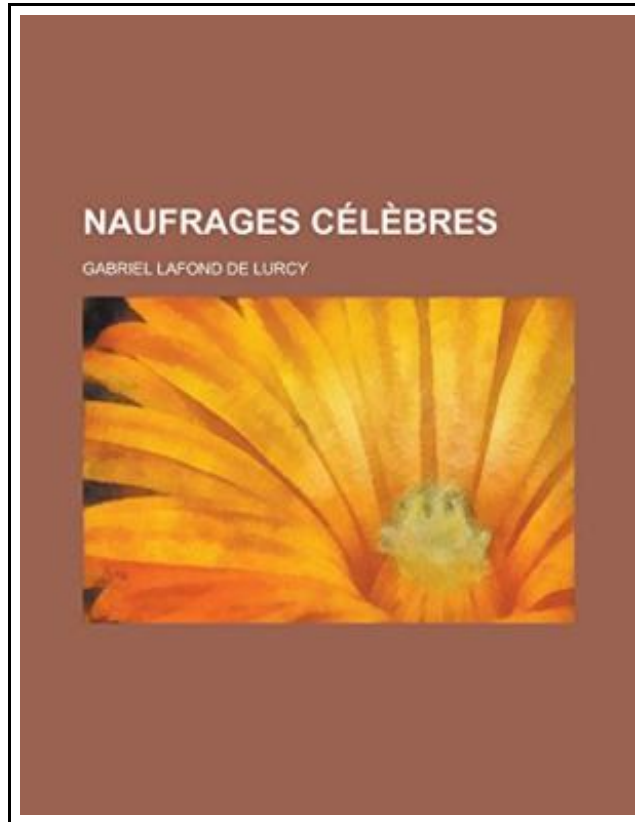

The crops raised were more than sufficient for the use of the school and the mirplus was sold and the proceeds devoted to the school.
